This article is devoted to the topic of inclusive economic development in the global dimension. The results of the work are relevant due to the introduction by the world community of an inclusive development index (to replace the GDP indicator for determination of the level of countries' success). The international comparison shows that countries with greater inclusion of the socio-economic system are more resistant to external threats and economic crises.

In modern conditions, constant economic growth needs inclusive development. The Chinese government, understanding the challenges of the future and the global problems of mankind, has taken a course toward internal development in conjunction with the openness and innovation of the economy. At present, China sees the priority of its actions in solution of socio-economic problems and formulation of the policy, aimed at protection of certain social categories and equalization of income. Thus, the policy of "small and confident steps" can probably bring fruitful and fast result in the socio-economic system of the country.
